Saturday, February 17, 1883

The merchants of El Paso met last night at Emerson & Berrien's old warehouse, on San Antonio street and erected the organization of the El Paso Board of Trade. A preliminary meeting had been held some weeks ago and a committee appointed to report a plan of organization. This committee consisted of Messrs. J. Julian S. Schutz, W.G. Walz, W. Emerson, W.M. James, M. Ullmann, and L.H. Davis. Last night they reported a plan providing for the organization of a board of trade, to be composed of the mercantile firms of El Paso and to be directed by a board of seven directors, this board to elect from their own number a president and vice president and from the body of the whole board a secretary and treasurer. An election was held which resulted in the following board of directors: J. Julian, J. Schutz, S. Schutz, M. Ullmann, C.L. Pierce, Z.T. White, and C.R. Morehead. This board then elected J. Julian president, C.R. Morehead vice-president, W.G. Walz secretary, and G.W. Emerson, treasurer. Messrs. L.H. Davis, M. Ullmann, and F.W. Merrick were appointed a committee to draft a constitution and by-laws and report at the next meeting, and a committee composed of Z.T. White, and C.L. Pierce was also instructed to memorialize the city council if at its meeting to-day, urging that no more franchises be granted to monopolies and that more especially no franchises be granted to what is known as the market house company. The board then adjourned to meet at the same place the evening of Friday, March 2nd. The following firms were enrolled as members

One of the most important events of the week thus far was the visit this morning of a number of prominent citizens to the site of the new school house, to inspect the brick that Schyster had hauled there to put into the walls of the building. As soon as he learned that his sun-dried brick were attracting attention he ordered them hauled back to the brick yard, claiming that they had got mixed up with the good brick by mistake. County Judge Rogers, Commissioner Julian, C.R. Morehead, Robert Campbell and others of our principal citizens saw the brick and as one of the party remarked, they resembled the three Hebrew children in that there was not even the smell of fire about them. We say this is one of the most important events of the week because it has convinced the public that the accusations of this paper against this utterly corrupt public official are true. We now ask the public why the term

“thief” should not be applied to rob and swindle, just as it would be applied to the miserable wretch who climbs over your back fence and steals your chickens. Why does not some citizen of the second ward who wants to see his ward respectably represented circulate a petition to the city council to expel him from that body? Why should his stores and houses and lands protect him? Will respectable men longer associate with him? If he were a *petty* thief every body would be spurning him. What reason is there that he should not be treated like any other thief!

Wednesday, December 9, 1885

Responsive to the call of the mayor and council there was a meeting of citizens at Schutz's opera house last night to discuss the proposed White Oaks road and meet Mr. Tibbitts, who represents the parties who propose to build it. Mayor Lightbody was elected chairman and W. B. McLachlen secretary. Mr. Tibbitts stated that the money for building the road was ready, and that he had been instructed to meet the citizens of El Paso and find out what amount of money they would donate, the money not to be called for until fifty miles of road bed had been graded. J.H. Britton with the remark that "talking don't build railroads, it takes money," offered to subscribe \$1,000 and thereby caused the subscription movement to start out with a great deal of enthusiasm; Judge Crosby offered \$1,000 and an additional \$1,000 if necessary, Mr. Detwiler offered \$1,000 for Mr. Satterthwaite; Mr. Campbell offered \$1,000; Mr. Bassett offered \$1,500 and the meeting was in a fair

way to raise \$50,000, when Messrs. Krakauer and Zollars expressed themselves as not in favor of immediate subscription and made a motion that a committee of five be appointed to solicit subscriptions, and after a great deal of discussion a vote was taken and the motion was carried. The chairman then appointed the committee as follows: J.F. Crosby, C.R. Morehead, A.M. Loomis, R.F. Campbell and Chas Davis.

14 YEARS AGO IN EL PASO

MARCH 11 [10], 1890

Two more suits are filed with Col. Baylor, clerk of the district court. Each case involves landed property to the value of \$1,000,000. One is the case of Ernest Dale Owen vs. Felix Galeros, for a large tract of land in Presidio county. The other is a suit brought by Merchant, Teel & Wilcox as attorneys for one Buchoz of Las Cruces, against C.R. Morehead, the El Paso Building & Loan association, et al, to try title to land in the southeastern portion of the city.

April 13, 1890

Charles Davis is appointed receiver for the White Oaks railroad and gives bond in the sum of \$120,000 with O.T. Bassett, R.C. Lightbody, C.R. Morehead, Joseph Magoffin and W.J. Fewell as securities. Colonel Human, who is interested in the road; judge Davis and Joseph Magoffin leave for Dallas, on a telegram from Jay Gould asking them to come there and talk over a prospective sale of the property.

May 2, 1890

Dr. E. Alexander in a published card denies the insinuation that he received the appointment of United States sanitary inspector at this place as a reward for political services rendered A. Krakauer during the memorable city campaign between Morehead and Krakauer.

February 13, 1891

O.C. Morehead is awarded the contract for burying county paupers.

March 6, 1891

President Harrison is invited to visit El Paso on his proposed tour of the western states. The invitation is signed by mayor Caples, Joseph Magoffin, E.B. Bronson, C.R. Morehead, B.H. Davis, W.S. McCutcheon, S.W. Russell, and A.M. Loomis.

June 15, 1891

As a committee to act in furthering the project of building the White Oaks roads, these men are appointed: S. H. Buchanan, mayor Caples, judge Blacker, E. B. Bronson, H. A. True, consul Sampson, W. S. McCutcheon, Charles Davis, A. M. Loomis, C. R. Morehead and H. L. Detwiler.

June 28, 1891

Engineer Campbell is busily engaged in surveying the property of the El Paso Real Estate company in the Morehead addition.

July 22, 1891

The contract to grade Austin street in the Morehead addition is let.

August 5, 1891

Among El Pasoans at Santa Monica are M.B. Davis and family, Mrs. Richard Caples, Mrs. Mrs. B.A. Nebecker, Mrs. C.R. Morehead, Mrs. A.M. Loomis, Mrs. Dan Kelly, Mrs. W.B. McLachlen, Mrs. W. H. Austin and Mrs. Maj. Teel.

September 5, 1891

C.R. Morehead returns from the east.

December 8, 1891

C.R. Morehead, president of the State National bank, recovers from an attack of the grip.

January 13, 1892

C. M. Williams of Colorado Springs, part owner of the Morehead addition, is in the city.

May 5, 1892

Mrs. C.R. Morehead and Mrs. Nebeker go to Santa Monica, Cal.

May 28, 1892

Miss Kate Moore and Miss Mira Newman leave over the Santa Fe for California. Miss Newman is to join Mrs. C.R. Morehead at Los Angeles.

Dec. 22, 1892

James Marr, in a communication to The Herald, supports Mr. Morehead for election to the school board.

Dec. 28, 1892

At the election of school trustees, C.T. Race, E.C. Pew, and C.R. Morehead are elected.

Jan. 9, 1893

The various companies of the fire department meet to form an engine company. Those appointed are Messrs. Morehead, Keys, Webber, Hickerson, Merrill, Stine, Farrell, Biggs and Payne.

Feb. 27, 1893

A baby girl is born to O.C. Morehead and wife.

Feb. 28, 1893

C. R. Morehead addresses a letter on or the silver basis coinage to senator P. B. Plumb, of the United States senate.

March 28, 1893

C.R. Morehead declares he does not want to run for office again.

May 23, 1893

C. R. Morehead, of the State National bank, leaves for St. Louis.

July 27, 1893

A pile of brush near the residence of judge Magoffin takes fire and the fire department make a long run to put it out. Joe Morehead is thrown out of a wagon and scrapes the ground with his elbow.

October 14, 1893

Mrs. C.R. Morehead is back from an extended visit to Chicago.

April 30, 1894

The bond of J.H. Smith, as assessor and collector, for \$20,000, with C.R. Morehead, E.C. Pew, Richard Caples and S.W. Pomeroy as sureties, was approved yesterday afternoon at a special meeting of the city council. Treasurer C.W. Fassett's bond, with Dan Kelley, B.H. Davis, C.R. Morehead, A.J. Calisher, Richard Caples and J.C. Lackland as sureties was also approved. G.C. Wimberly's bond was signed by S.W. Pomeroy and C.R. Morehead.

May 14, 1894

The family of president Morehead, of the State National bank, leave today for Los Angeles, where they have a summer home.

August 12, 1894

Mr. Schutz's funeral was one of the largest, if not the largest funeral ever held in El Paso, and it will be long remembered. The services were delayed, however, until Jos. Schutz's daughter could arrive from Albuquerque on the 9:45 train, by which time scores of citizens had gathered to pay their last respects to a valued citizen. The burial was under Masonic auspices, conducted by E.C. Pew, but there were also Jewish exercises in English conducted by I. Haas, owing to their being no rabbi in town. . . . The body bearers were Dr. Vilas, Joseph Magoffin, C.R. Morehead, John Julian, A. Solomon and I. Hass; and the pall bearers: W.W. Mills, A.K. and M.R. Krakauer, E.B. Fat-

man, B. Blumenthal and E. Kohlberg. The procession included the Masons, sixty strong, the hearse, with fine carriages with mourners, police force under chief Milton, the fire department with seventy-five men, and then some sixty or seventy carriages and vehicles.

August 29, 1894

"Oh, won't there be a whole lot of fun this fall, though, in country politics," remarked a prominent business man today. "There is a red hot time on in the local Democracy between the Johnson-Morehead faction and the younger element, and if the first party gets the upper hand the other branch of the family will bolt, and then the Republicans will win the day. Moreover, if Dean is slaughtered at Henrietta, which is likely, he will come home with fire in his eye, and the cotton flying from his teeth, spoiling for a political scrap; and besides, Alf Hampton is aching for a row."

September 23, 1894

Dick Rule, editor of The Herald during the famous Krakauer-Morehead campaign, and one of the raciest writers in the country, takes charge of the columns of The Tribune today. (Rule died in El Paso last Friday night)

September 24, 1894

C.R. Morehead has returned from California.

October 16, 1894

At a meeting of citizens this morning to arrange for the entertainment of the governor tomorrow, the following committee was appointed: Chairman, H.B. Barnhart; W.M. Yandell, C.R. Morehead, Leigh Clark, W.W. Turney, C.B. Stevenson and Juan Hart.

October 19, 1894

Governor James Hogg, the chief executive of the greatest state in the union, arrived this morning over the Texas & Pacific and was met at the depot by several hundred pleased citizens and officials, headed by the McGinty band of 25 men. The reception committee was on hand, and with them were municipal, county, district and federal officials from the other side of the river. The long procession of carriages was headed down the street by mounted state and federal and local officers and the McGinty band and a large following of citizens came afterwards. His excellency occupied the first carriage, with judge C.N. Buckler, whose guest he was, mayor Johnson, and chairman C.R. Morehead. December 15, 1894

At a meeting of the city council last night, the clerk reported the filing of treasurer F. Bassett's new \$40,000 bond, with C.W. Fassett, Dan Kelly, C.R. Morehead, H.H. Davis, J.C. Lackland, Joseph Magoffin, Richard Caples and J.U. Dieter as sureties.

December 23, 1894

The East El Paso Land company called a meeting this afternoon to grant a right of way to the El Paso, Chicago & Mexican road—that is the White Oaks road. Contractor Bell says he has secured contracts for the entire right of way from this city to the New Mexico border, except through the property of C.R. Morehead, located east of Pridham, and the friends of the road hope that Mr. Morehead will see his way clear to give the company the land necessary for the right of way. The names of the public spirited citizens who have given lands are Maj. Noyes Rand, the Campbell Real Estate company, O.T. Bassett, Horace Broadus, Francis Bruner and Ben Russell.

December 28, 1894

Judge Blacker was on both of the school tickets today, so his election is sure. What is called the "Morehead" ticket contains also the names of J.H. Harper and T.J. Beall, while the so-called anti-Morehead ticket had the names of E.A. Shelton and A.G. Foster. It was considered a fight for and against the kindergarten

December 29, 1894

J.H. Harper says his name was used as a candidate on the so-called Morehead ticket

without his consent. He did not proposed to run.

It was given out yesterday that the members of the board of education were not personally interesting themselves in the election, but it was noticed that the mayor was driving from house to house distributing the so-called Morehead ticket: and, moreover, officer Sanchez and janitor Paul, of the high school, were seen actively at work in favor of the same ticket. Then, besides, the secretary of the school board was a judge of election in the third precinct. The county treasurer and the president of the board were also seen about town imitating the busy little bee that improves each shining hour, and on the whole the school board appeared to be very much interested in the success of the so-called Morehead ticket. But alack, alas, that ticket was snowed under.

January 8, 1895

The first meeting of the new board of education was held last evening with Messrs. Morehead, Johnson, Pew, Blacker, Rice, Hunter, Shelton, and foster present. The following officers were elected: president, Dr. C.T. Race; vice president, Allen Blacker; secretary, E. C. Pew; treasurer, E.A. Shelton. President Race announced the following standing committees. Finance, A.G. Foster, E.C. Pew; internal arrangement, judge Blacker, C.R. Morehead; external arrangements, E.A. Shelton, Dr. Race.

April 12, 1895

Maundy Thursday was celebrated last night in Masonic hall with a banquet by the 32d degree Masons, with collector Bauche, of Juarez, a 33d degree Mason, as guest. The following were present: Col. May 11, 1895

Mrs. C. R. Morehead and Mrs. Nebeker and family left at noon on a California trip.

May 28, 1895

The board of education held a called meeting yesterday in the central school building, Messrs. Morehead, Pew, Shelton and Foster being present. Prof. Aoy's salary was ordered paid, and it was decided that in future salaries of teachers should be paid as they are earned. An effort will be made to borrow money from the banks to provide a fund for this purpose. On account of Miss Baron not being an applicant for next year, the treasurer was ordered to pay her the balance of her salary for the present year.

May 29, 1895

The ten-mile bicycle race which is to come off tomorrow has been arranged and the entry lists have been closed. The starters for the various events will be Walz, Hawcroft, Bushong, Bovee, Morris, Bridgers, White, Watson, Porcher, Smith, Hampton, Paul, Grandover, Lane, Hood, Rand, Canales, Julian, Race, Welch, Rokahr and Davis. Officers, committees, etc., are as follows: Judges, C.R. Morehead, E.C. Pew and Jos. Magoffin. Timers, W.G. Walz, J.M. Leitch and P.E. Kern. Handicap committee, Ed. C. Pew. W.F. Payne and Vincent P. Ring. Referee and starter, D.W. Reckhart. Checkers at the bridge, W.H. Shelton and E.V. Berrien. Clerk of the course. Vincent P. Ring. The race will start from in front of the residence of judge Wilcox on Myrtle street.

July 21, 1895

Undertaker Morehead says the county road between Dunn's saloon and Comstock's, which is still under water, is all cut to pieces

by the teams which plow through the water. Mr. Morehead says the water has been drained off Evergreen cemetery.

August 6, 1895

Congressman Cockrell with his wife and daughter arrived this morning from Austin and were escorted to the Vendome hotel by Collector Davis and C.R. Morehead. He said that he came here principally to look over the dam project.

city limits. The superintendent reported that he had received \$200 as a nucleus to form a library fund and he would endeavor to secure \$400 more.

Morehead is the only candidate for the office yet to appear, and he will doubtless be elected.

April 7, 1899

At the school board meeting last night, all members were present except W.R. Martin. Besides the members of the board were superintendent Putnam, architect Kneezell, Mr. Hill, city attorney Kemp and attorney Burges. The resignation of judge Allen Blacker was accepted and it was resolved that a successor be appointed and a president elected. Mr. Foster nominated Dr. T.S. Turner for president and C.R. Morehead as successor to judge Blacker, and they were unanimously elected. As the sale of the bonds placed a much larger sum of money in the hands of the treasurer, it was ordered by the board that he give an additional bond of \$15,000.

April 11, 1899

Last night's crowd assembled in front of the Republican headquarters is a revelation to many. It served to indicate the strength of John O'Keefe. A meeting was held at Union labor hall last night and was addressed by George Wallace and Willie Bridgers, C.R. Morehead attended the meeting.

April 12, 1899

Joseph Magoffin was elected mayor of El Paso yesterday by the biggest majority ever given any candidate in this city before. The triumph of the officeholders was a glorious one and they rejoiced last night by building bonfires, delivering orations and serenading

Magoffin and Morehead. The second ward was nearly unanimous for Magoffin. The full Democratic ticket was elected which will make the council entirely Democratic. On the whole, the election was quiet and orderly during the day, for O'Keeffe gave up the fight and practically quit the race early in the day. The entire vote for Magoffin yesterday was 1914 and that of O'Keeffe 711. There were exactly 1277 more votes cast yesterday for mayor than the last mayoralty contest when these were [undecipherable] Magoffin defeated O'Keeffe by a majority of exactly 1200.

April 22, 1899

The school board at its last meeting elected a president. Dr. S.T. Turner, to succeed Dr. Chas. T. Rice, and also elected C.R. Morehead to fill the vacancy of judge Blacker, resigned. The term of school superintendent being about to expire, Mr. Martin moved that Prof. G.P. Putnam be reelected for two years at a salary of \$1800 per year. The motion was carried and Mr. Putnam was chosen superintendent for a term of two years more. The bids for the Mesa school addition were regarded as too high and it was finally determined to call for bids for a two room addition to the building.

May 3, 1899

There was no hearing of the mandamus case of Dr. Race vs. the school board in the district court this morning, for the reason that the matter had been compromised. The board meets tonight and at the meeting C.R. Morehead and Dr. Turner will withdraw and Capt. T.J. Beall will be elected to fill the vacancy caused by Morehead's withdrawal. Dr. Race will continue to act as president and another member of the board will be elected by the people.

May 5, 1899

At the adjourned meeting of the school board last night Messrs. Morehead, Race and Pew stayed away, but business went right ahead without them, as there was a quorum present. Messrs. Turner, Martin, Shelton and Foster answered to the roll call. Dr. Turner presided and Mr. Shelton acted as secretary. Superintendent Putnam submitted his report for April, showing that 1672 pupils are now enrolled. The president wanted to know if it was not about time school census should be taken and Professor Putnam said that as only a month remained in which to take the census he had taken the liberty of putting Jake Catlin to work enrolling names. Frank Powers presented his bid for the Mesa school addition.

May 9, 1899

This afternoon the petition, of Dr. Charles T. Race, formerly president of the school board, for a writ of mandamus to compel Messrs. Martin, Shelton and Foster, other members of the board, to recognize him as the lawful president of the board instead of Dr. S.T. Turner, came up for a hearing. There were present Messrs. Morehead, Pew, Foster, Putnam and Turner and about 25 lawyers and spectators. Attorneys Beall and Kemp and judge Buckler represented Dr. Race, Turney and Burges represented Dr. Turner.

May 12, 1899

A warm wrangle took place in the district court this morning between W.H. Burges, attorney for Dr. Turner and Messrs. Beall and Kemp and Patterson and Buckler for Dr. Race. During the progress of the debate, Dr. Turner was styled an interloper by Capt. Beall and attorney Foster was reproved by the captain for bringing up the name of Mr. Morehead.

May 16, 1899

C.R. Morehead met at the Central school building last night with E.C. Pew, Dr. Race and A.G. Foster and they transacted such business as came before them. Prof. Putman then submitted his report. The communication of the Newman Carrol-Brick company was read, by Mr. Pew. Mr. Morehead moved that Mr. Putman, be reelected superintendent for the ensuing two years at a salary of \$1800 per annum. The nomination was seconded by Mr. Pew. Dr. Race announced that C.R. Morehead, as successor to judge Blacker, would serve on the same committees on which Judge Blacker formerly served. Prof. Putman was authorized to rent Chopin hall and the opera house for commencement exercises.

May 17, 1899

C.R. Morehead, E.C. Pew, Dr. Race and E.A. Shelton met at the Central school last evening to transact further school board business. Buchanan & Powers were awarded the contract for enlarging the Mesa school, at a cost of \$4750, the work to be finished September 1. The contract for the Mexican school was not decided upon.

Fourteen years ago today, El Pasoans met in a monster mass meeting to endorse the government's course in the war against this Philippine Insurgents. Democrats and Republicans united to voice their approval of the government's course. The meeting was held in the Myar opera house and was called to order by A. Krakauer. Capt. T.J. Beall presided and patriotic addresses were made by Capt. Beall, judge W.M. Coldwell and others. Reference was made in the resolutions adopted to a previous meeting held in the court house which criticized the course of the government. Resolutions, were adopted repudiating the proceedings of the previous meeting and pledging earnest and united support to the government in its efforts to "maintain its rightful authority in the Philippines." The resolutions were signed by T.A. Falvey, J.M. Dean, C.R. Morehead, H.L. Newman, F.B. Sexton, R.F. Burges, Adolph Krakauer, W.N. Villas, U.S. Stewart, and W.M. Coldwell, as a committee appointed to draft its resolutions.

June 7, 1899

Yesterday afternoon a brief session of the school board was held at E.C. Pew's with all members present. The bonds of treasurer A.G. Foster were submitted and approved. One was his regular bond for \$20,000, which was signed by J.A. Smith, Leigh Clark. A.P. Coles, H.B. Stevens, W.H. Burges, and S.T. Turner. The other was a special bond for \$15,000, and signed by J.A. Smith, C.R. Morehead and Charles Davis.

August 8, 1899

When the school board met last night for the regular monthly meeting the following trus-

tees were present: Martin, Shelton, Pew and Morehead. In the absence of president Race and, on motion of Mr. Morehead, W.R. Martin was made chairman. The resignation of Miss Julia Owens was read and accepted. On recommendation of architect Kneezell, the bid of T.J. Holland for blackboards at 35 cents per square yard was accepted. A complaint was read by secretary Pew from the water company in which the company called the attention of the board to the extravagant use of water by the janitor in irrigating the trees.

August 18, 1899

A stockholders' meeting of the proposed Athletic association was held in the Catholic library rooms this morning with the following present: J.J. Connors, C.R. Morehead. Zack T. White, C.F. Jones, Juan S. Hart, T.C. Lyons, Charles Schultz, Moses Dillon, Ed Kneezell, R.C. McDonald and Charles Beisswenger. On motion of J.J. Connors, Juan S. Hart was elected chairman and Park Pitman secretary. Chairman Hart submitted a draft of a constitution and bylaws which were adopted by the association.

August 22, 1899

The midwinter carnival committee held another meeting last night to hear the report of the soliciting committee composed of Messrs. Powers, Albers and Ryan. U.S. Stewart, Dr. A.K. Albers, Frank Powers, R.C. Hunter, W.W. Bridgers, colonel Buford and A. Daguerre were present. Chairman Powers reported that the committee has already secured pledges from responsible citizens for over \$3000. The following were appointed to act as an executive committee: Juan S. Hart, A.K. Albers, Frank Powers, J.J. Taylor, U.S. Stewart, C.R. Morehead, A. Krakauer, Charles Davis, D.W. Reckhart. W.J. Fewel, H.D. Slater, W.G. Walz, W.W. Bridgers, A. Courchesne, A.A. Howard. J. Calisher, T.H. Springer, T.A. Falvey, H.L.

Newman, F.E. Hunter, C.B. Eddy, Britton Davis and Felix Martinez.

August 27, 1899

Capt. Juan S. Hart, the chairman, and a few others were present at the Carnival committee, meeting last night at Fireman's hall. A program was submitted by F.E Hunter, A.A. Howard and Felix Martinez. The chairman appointed a finance Committee consisting of the followings: A. Courchesne, A.K. Albers. Frank Powers, Felix Martinez, U.S. Stewart, A. Krakauer and C.R. Morehead. The chairman of the executive committee announced that since he had been empowered to appoint a secretary, he had decided to appoint Dr. George T. Gould to that office.

September 16, 1899

The carnival committee is making urgent appeal to the citizens of El Paso to help make the mid winter carnival a success. The committee is as follows: A. Courchesne, A.K. Albers, Frank Powers, U.S. Stewart, C.R. Morehead, A. Krakauer and Felix Martinez.

September 18, 1899

Yesterday afternoon at 8 o'clock two of El Paso's most popular young people were married. They were L.M. Turner, who for several years has been identified with the State National bank, and Miss Jennie May Walz, the accomplished daughter of W.G. Walz. On account of the departure Tuesday of Harry Walz, brother of the bride, it was decided to have the wedding Saturday, Miss Leila Trumbull was bridesmaid, and George Flory groomsmen. Those present at the wedding were: H.S. Walz, W.G. Walz, Dr. Brady and mother, Mr. and Mrs. J.C. Lackland, C.R. Morehead, Mr. and Mrs. C.E. Kelly; Misses Irma and Bella Schultz, Miss Maggie Lyon and a few other intimate friends. The young couple will reside on Mesa avenue.

September 24, 1899

There will be no mid-winter carnival. This question was settled yesterday afternoon when the executive committee met at the court house. The executive committee was not discharged but will remain in office to arrange for a carnival in 1900. Each member of the committee was assessed \$4 to pay the expenses incurred. Mr. Morehead, of the committee gave \$10 to the fund and other members paid amounts exceeding the assessment.

September 25, 1899

By invitation of proprietor Fisher, of the Pierson, and also of the new Hotel Sheldon, and that of Messrs. Courchesne, Morehead and Martinez, nearly 50 prominent business and professional men gathered at the Pierson to celebrate the success of the plan to make a fine large hotel out of the Sheldon block, and to bid farewell to Mr. Sheldon's representative, Mr. Parfitt, The large table had been arranged in the form of a V with covers laid for sixty. At the apex sat mayor Magoffin, Mr. Parfitt, captain Beall and Mr. Kerr.

October 3, 1899

The school board met last night with secretary Pew absent. E.A. Shelton was chosen secretary protem. Superintendent Putnam submitted his report for September which was quite lengthy. Jake Catlin was allowed \$100 for taking the school census. The superintendent recommended this in view of the fact that he fees are insufficient for the amount of work done. Mr. Morehead asked as to the possibility of paying September warrants. The external committee was authorized to receive bids for coal to supply the city schools during the winter. Prof. Putnam asked that an appropriation be made for supplies needed in the schools.

October 18, 1899

C.R. Morehead and Alfred M. Winberg deeded to J.A. Marquez lots 15 and 16, in block 58, Campbell's addition, for a consideration of \$300.

October 30, 1899

C.R. Morehead and family have returned from California, where they were sojourning this summer.

November 7, 1899

There being no quorum present at the meeting of the school board last evening a meeting was held at four o'clock this afternoon in the office of secretary E.C. Pew. Those present were: C.R. Morehead, A.C. Foster and E.C. Pew. Architect Ed Kneezell said that all of the new school houses had been completed and everybody paid off. There were over \$2700 worth of bills to be paid and treasurer Foster reported that there was only \$400 in the special fund to meet them.

November 8, 1899

Messrs. Race, Pew, Foster and Morehead, members of the school board, constituting a quorum, met at the office of treasurer A.G. Foster in the federal building last evening. It was voted that Miss Fitzpatrick's salary continue while she was ill. A letter was read from Maria J. Gallagher, principal of the Second ward school, stating that the building had been named the "Alamo" by the teachers of the school.

November 11, 1899

Superintendent W.R. Martin went to Lasca yesterday in his private car and let the contract for drilling there to James Brown, who was successful in striking good water at Sanderson, Texas. Arrangements have been completed with Messrs. C.R. Morehead and T.J. Beall, owners of the land on the mesa, for the sinking of a well there.

November 26, 1899

Citizens generally are expressing their disapproval of the action of the city council in refusing to furnish the library rooms in the new city hall. C.R. Morehead stated this morning that he was strongly in favor of furnishing the library and reading room at once.

December 15, 1899

A military ball will be given by the Border Rifles at the court house January 4. The following will compose the reception committee: Mayor and Mrs. Joseph Magoffin, Mr. and Mrs. W.N. January 17, 1900

February 6, 1900

The school board met in regular session last night for the first time in two months. There were present Dr. C.T. Race, C.R. Morehead, E.C. Pew, A.G. Foster. The absentees were E.A. Shelton and W.R. Martin. The total enrollment of the schools up to date is 1845; average daily attendance, 1400; for December, total enrollment, 1742; attendance, 1400. The question for sites for the new school houses was brought up and Mr. Fos-

ter said that he thought that a satisfactory one could be had on the hills in the fourth ward, now owned by the El Paso Commercial company.

February 13, 1900

During last December C.R. Morehead, P.W. Pitman. W.H. Tuttle and George Look were elected members of the "Sons of the Revolution," the Texas headquarters of which are located at San Antonio. Invitations have been received by them to attend a dinner in New York City, to be given by the society.

March 6, 1900

The regular monthly meeting of the school board was held last night at the office of superintendent G.P. Putnam at the city hall. Superintendent Putnam submitted the report of the city schools for the month of February. The matter of compulsory vaccination of school children was laid before the committee. Treasurer A.G. Foster asked permission to transfer a small amount remaining in the bond fund to the general fund. The question for new school sites again came up for consideration. As there are a number of outstanding claims upon the site adjoining Buckler square to be adjusted a committee of Dr. Race, C.R. Morehead, W.R. Martin and A.G. Foster, was appointed to confer with the members of the city council about the matter-and to inquire concerning a location in the first ward.

April 3, 1900

The school board met last night in the superintendent's office in the city hall. There were present Dr. C.T. Race. A.G. Foster, C.R. Morehead and E.C. Pew. Absent were W.R. Martin and E.A. Shelton. Superintendent Putnam submitted a verbal report the condition of the public schools during the month of March. The professor stated that the school exhibit for state teacher's convention was in course of preparation. Professor

Putnam called up the matter of adjournment for summer vacation and it was decided by the board to close the schools on May 18.

April 9, 1900

C.R. Morehead and family are visiting in California.

April 21, 1900

El Paso should have a government mint. By right of the production of gold in the territory contiguous to this city a mint should be located here. W.A. Seamon, manager Earle, of the El Paso smelter, D.W. Reckhart and president Morehead, of the State National bank, are in sympathy with the movement. Upward of \$10,000,000 worth of bullion passes through or is produced annually in the country tributary to this city. By the location of a mint here, hundreds of mine owners would be saved freight charges.

April 23, 1900

The proposition to establish a purchasing mint in El Paso is gaining popularity among prominent El Paso citizens. President Morehead, of the State National bank, stated today that he endorsed the call made by president Freudenthal, of the chamber of commerce to the mining committee of that organization to take up the matter. President Juan S. Hart of the committee, is out of the city at present but will return within a short time.

April 28, 1900

Last night's session of the city council was a busy one. Alderman Clifford, who is on his way to Paris, and alderman Geo. Ogden were the only absentees. The report of the city clerk showed 27 building permits issued for buildings valued at \$2585 during the past month. The bonds of city officials were approved as follows: Treasurer Fasset's bond of \$40,000, presenting as sureties Dan Kelly. C.R. Morehead, A.A. Howard,

Charles Davis, J.C. Lackland, T.J. Beall and A. Loomis; J.H. Smith, assessor and collector, presenting as sureties C.R. Morehead, A.P. Coles, C.E. Kelly, Millard Patterson and A. Courchesne. Major Magoffin called up the question of opening Kansas street.

May 2, 1900

The regular election for members of the school board, under the new law, will take place Saturday of this week, May 5. There are seven members to be elected including the president. Of the present board, all members are to stand for reelection except Dr. C.T. Race and A.G. Foster. The ticket that will be put out Saturday—as far as anyone knows—consists of C.R. Morehead, E.C. Pew, W.R. Martin and E.A. Shelton of the present board, and Dr. F.W. Gallagher, J.F. Williams and Dr. M.O. Wright.

May 6, 1900

The election of school trustees yesterday resulted in the selection of the compromise ticket agreed upon by the Democratic and Republican leaders in order to avoid a political fight. There were scattering votes cast in several of the wards for Capt. T.J. Beall, Waters Davis, Dr. Higgins, C.W. Fassett and P. Millsbaugh. The ticket elected consists of: W.R. Martin, E.C. Pew, E.A. Shelton, F.W. Gallagher, J.E. Williams, C.R. Morehead and M.O. Wright.

May 9, 1900

Last night the new school board met for the first time in regular session in accordance with the new school law. The first business was the division of the members into long and short terms. J.F. Williams, F.W. Gallagher and M.O. Wright secured the long terms, and E.C. Pew, W.R. Martin, C.R. Morehead and E.A. Shelton, the short term. The board then organized by electing C.R. Morehead president; Dr. F.W. Gallagher,

vice president, E.C. Pew, secretary, and J.F. Williams, treasurer.

June 5, 1900

March 29, 1901

At this time of intense political excitement "Boss" C. R. Morehead absolutely refuses to express any views on the announced candidates, candidates who may announce later or what the probable outcome of the election will be. Those who are backing the candidacy of Maj. B.F. Hammett have already organized and it is certain that whoever is put up against him will have a hard fight. After an apathy of weeks, public interest in the coming contest is now aroused.

April 8, 1901

F.N. Baca has been granted a permit to build two \$1400 residences in the Morehead addition.

May 4, 1901

The election in progress today for the purpose of selecting four school trustees to serve during the ensuing term is passing off quietly in the various wards. There are two tickets in the field and the contest is somewhat spirited. One ticket bears the names of C.R. Morehead, E.C. Pew, W.R. Martin and E.A. Shelton, the present members of the board. January 7, 1902

January 22, 1902

Officers for the ensuing year were elected at a meeting of the executive board of the International Miners' association yesterday as follows: J.S. Eldridge, first vice president; James Calhoun, second vice president; William C. Greene, third vice president; M.W. Wambaugh, fourth vice president, J.W. Fleming, fifth vice president. C.R. Morehead was reelected treasurer and A.W. Gifford, secretary.

February 22, 1902

March 4, 1902

Miss Bessie Williams at her home on North Kansas street, entertaining a few of her friends Saturday evening. Those present were: Misses Grace Carr, Mary Phinney and Louette Robinson and Messrs. Baldwin, Will C. Perry and Philip Morehead.

March 13, 1902

C.R. Morehead left for Santa Monica, Cal.

March 30, 1902

C.R. Morehead, accompanied by Mrs. Morehead, is expected to return from Santa Monica tomorrow. They have been gone for several weeks.

May 3, 1902

The new school board, Dr. Howard Thompson, John H. Harper, J.H. Smith, Pat Dwyer, C.R. Morehead, John Doe and Prof. G.P. Putnam won in the school election Saturday. The majority for the winning ticket was

about 220. The closing scenes of the elections marked hard fighting, although it was conceded during the afternoon that the Morehead ticket would win by a safe margin. The defeated candidates are Drs. M.O. Wright and Francis Gallagher and J.F. Williams.

June 23, 1902

August 17, 1902

A Mass meeting of citizens will be held tonight at the city hall at which the question of the recent raise in water rates will be freely discussed. As yet no plan has been mapped out but it is likely that Juan Hart. J.M. Dean. W.W. Turney, C.R. Morehead and judge T.A. Falvey will be called upon for speeches. There is considerable interest being shown in the meeting and a large crowd is expected.

September 5, 1902

A company for the improvement of Washington park as a public recreation ground is being organized in the name of the Boone Athletic Park and Improvement association, with a capital of \$100,000. The earning of the company will be divided among the stockholders according to the individual amount invested. The directors of the company are: W.W. Turney, Charles R. Morehead, J.H. Boone. Capt. Charles Davis, U.S. Stewart, T.M. Wingo, Felix Martinez, C.E. Kelly and J.B.W. Burton.

September 9, 1902

According to a dispatch from Austin, the Boone Athletic Park and Improvement association, of El Paso, with a capital stock of \$100,000 was incorporated by J.H. Boone, U.S. Stewart, C.R. Morehead, Charles Davis and others.

September 22, 1902

It is claimed by several of the newly organized labor union party that overtures have been made by the Morehead faction of the Democratic party for fusion with the former organization for the city campaign. The first proposition, it is said, was an offer of four councilmen and a goodly number of paid officers.

September 30, 1902

The Texas Bankers' association and the state association of commercial clubs have jointly appointed committees to entertain the Chicago bankers, who are to visit the state in October and those named for the 16th congressional district are: C.R. Morehead, mayor; B.F. Hammett and E.M. Hall.

October 19, 1902

The coming municipal campaign from present appearances will be a many sided affair. The union labor party will be in the fight if

the plains are not altered and it is generally believed that mayor Hammett will lead a ticket for reelection. Then the Republicans have virtually decided to get into the game for at least a part of the offices and it is said that both W.W. Turney and C.R. Morehead will head tickets in the primaries.

October 31, 1902

Chairman W.W. Turney, of the general committee for the entertainment of the Cattle Raisers' association of Texas, has appointed the following entertainment committee: B.F. Hammett, Capt. Charles Davis, H.L. Newman, C.R. Morehead, U.S. Stewart, J.G. Hilzinger, Felix Martinez, A. Solomon, A.P. Coles, Francisco Mallen, E. Kohlberg, V. Onate, P.F. Edwards, J.M. Dean, J.H. Boone, Joseph Magoffin, F.B. Stewart, C.M. Tibbetts, W.L. Gaines and P. Garrett.

November 7, 1902

The Republicans are lining up for the city election and are already making plans for a ticket which they will put in the field. The Republicans do not look for B.F. Hammett to be the nominee again and declare that it lies between C.R. Morehead and W.W. Turney.

November 11, 1902

There are meetings every once in a while to discuss the union station matter and the citizens are showing that they are alive to the interests of the city and anxious to have the stations located. Yesterday afternoon there was a meeting at which C.R. Morehead, H.L. Newman and U.S. Stewart were appointed as a committee to receive subscriptions for the land which it is necessary to buy in order to remove the Sunset railway tracks from San Francisco street.

November 21, 1902

There has been quietly organized in El Paso a mining company of which the officers are: C.R. Morehead, president; J.U. Sweeney, secretary; J.A. Rogers, general manager, and the board of directors are C.R. Morehead, J.A. Rogers, D. Storms, Charles Davis and J.C. Lackland.

December 6, 1902

Politicians who claim to know, declare that C.R. Morehead has definitely decided to enter the race for mayor in the coming city election and that he and his friends are already making plans with that end in view. No public or official announcement has been made to this effect, however, but it is generally believed that Mr. Morehead will be in the race without a doubt. Senators W.W. Turney's friends have not said much lately about his candidacy.

December 14, 1902

A meeting was held in the chamber of commerce yesterday afternoon to discuss the proposed excursion over the El Paso & Southwestern railway, the decision being to take a trip as soon after the first of the new year as possible. A committee of which T.M. Wingo is chairman was appointed to make all necessary arrangement for the excursion and that committee as named by president Bray is as follows: T.M. Wingo, S.J. Freudenthal, Felix Martinez, J.D. Ponder, W.W. Fink, A. Courchesne, R. Caples, U.S. Stewart, C.N. Tibbits, H.D. Slater, C.R. Morehead, J.G. Hilzinger, E. Kohlberg and E. Moye.

December 19, 1902

The political plot continues to grow thicker each day and affairs get warmer. The latest mayoralty candidate mentioned by the "clean politics" wing of the Democrats is Chief of Police James White and although he has not yet consented to run he acknowl-

edges that he has the matter under consideration, and in the event W.W. Turney will not run he is the man looked upon as able to beat C.R. Morehead.

December 23, 1902

C.R. Morehead, R.C. Lightbody and W.L. Gaines have been appointed jury commissioners to select grand and petit jurors for the January term of the district court.

January 2, 1903

The latest talk among the Democrats is reconciliation and a compromise candidate for the mayoralty, just as the Republicans have been predicting all along. It is said that efforts are being made to bring the Morehead and the Hammett-Turney factions together, and there are prospects of success. The overtures for peace are said to have come from the Morehead people.

January 6, 1903

From the way both factions are paying their poll taxes it looks a good deal like the attempted to heal the wounds of the Morehead and the anti-Morehead crowd of Democrats together has failed. It is now the talk that Morehead will fight to a finish and the other faction is just as determined, so a hot fight is promised. The proposed compromise was to save the expense of paying so many poll taxes.

January 9, 1903

The city council passed an ordinance last evening adopting the Australian ballot system and was ordering registration for the coming city election. This, it is declared, will result in a clean election. This, it is declared, will result in a clean election for the city and is a part of the program of the anti-Morehead faction to shutout illegal voters. At the meeting alderman J.B. Badger recommended the erection of a bridge over the canal on Tays street.

January 10, 1903

C.R. Morehead, who has made his formal announcement for the mayoralty nomination on the Democratic ticket when asked if there was any truth to the report that Joe Rogers would be his chief of police, said that he believed he had answered when he said that if elected his administration would be free "from prejudice and promises."

January 18, 1903

There was a very interesting meeting of the delegates to the Union Labor party in the Masonic temple this afternoon. For several days it has been poised about that "Kid" Hadlock and Ike Alderete would attempt to have the meeting endorse C.R. Morehead for mayor, but they were defeated by a move of the opposition, headed by N.L. Griest.

January 22, 1903

The Morehead supporters have been busy all day getting ready for the primaries, but there is very little herding of voters. The anti-Morehead or white Democrats will not enter the primaries.

January 23, 1903

The Democratic primaries were pulled off last evening and they were harmonious. Wards one, two and three instructed their delegates to vote for C.R. Morehead and ward No. four sent up a solid Morehead delegation without instructions. The anti-Morehead men were not present, because they declared that the action of calling the convention a so early was unprecedented and that it should be delayed until after registration.

January 24, 1903

The city Democratic convention met today and nominated a full ticket for the offices of the city government. C.R. Morehead was unanimously nominated for mayor. Only

four of the present city officials were nominated on the ticket—Ben F. Jenkins for city assessor and collector; George C. Wimberly, for surveyor, and W.J. Rand and George Look for aldermen. J. George Hilzinger was nominated for treasurer, and A.S.J. Eylar for police judge. The ward aldermen are as follows: First ward, George Look; second ward, James Magoffin; third ward, Henry Welsch; fourth ward, Ben Catlin.

January 30, 1903

There is a very persistent rumor about the streets that J. Geo. Hilzinger, who is running for city treasurer on the Morehead ticket, will soon withdraw his name from the ticket and that the name of J.H. Smith will be substituted.

February 1, 1903

City attorney John L. Dyer, acting as attorney for a client, has since Saturday been offering \$1000 even that Morehead will not be the next mayor of El Paso and up to noon today had found no takers. He says that \$4000 more will be posted if the first \$1000 is covered.

February 2, 1903

Since Saturday there have been many political rumors about the streets and a number of developments. The Morehead men started the report that Capt. James H. White was going to close the gambling houses, but this was emphatically denied by Capt. White and his campaign manager. The report also spread that the police were electioneering for Capt. White, and this was also denied.

February 5, 1903

J. George Hilzinger has withdrawn from the race for the city treasurer's position on the Morehead ticket and as yet his successor has not been appointed. J.H. Smith, the former city assessor and collector, seems to be considered more favorably than any other man.

February 6, 1903

The statement made by J. Geo. Hilzinger last evening regarding his withdrawal from the Morehead ticket has caused a great deal of talk among the politicians and the disclosures he made has created dissatisfaction among the Morehead supporters.

February 7, 1903

The United Brotherhood of Railway employes' smoker last evening proved not only a nice time socially but also a very good political meeting and some secrets were given away by prominent leaders of the labor party. W.G. Roe told the meeting that he had received on after of a certified check for \$3000 from Morehead faction if he would take a trip to New York for two months.

February 9, 1903

The labor party's ticket, which will doubtless receive the endorsement of the Republicans and the anti-Morehead Democrats, will be placed in the field tomorrow evening, at a meeting to be held in the court house.

February 14, 1903

Fred Delgado, one of the policemen who recently gave up his star to support the Morehead ticket, was married today at 3 o'clock to Miss Maria Russick. Capt. Wm. Mitchell, of the police force, acted as best man.

There was a meeting of young Democrats, supporters of the Morehead ticket, in the county court room last night and resolutions were adopted endorsing the Democratic party. Frank Morrison was elected president of the organization and the other officers chosen were: Secretary, C.W. Marshall; treasurer, J.R. Harper; vice president, M.R. Robinson; vice president, second ward, W.E. Swearingen; vice president third ward,

Frank Weber; vice president, fourth ward, Sam Blumenthal.

February 19, 1903

The Morehead campaigners expect to prevent the use of the registration certificates of the city in the coming election. The rumor was current today that injunction proceedings had already been instituted before judge A.M. Walthall to prevent city registrar W.M. Peticolas from qualifying.

February 20, 1903

Since the city council last evening turned down the petition of the Morehead supporters for more voting places in the second and third wards, it is said that the county commissioners court will do this work. 'The commissioners cannot legally do much a thing, however, according to the city attorney and other lawyers.

February 26, 1903

The meeting last night of the Young Men's White club was a rousing affair. Upwards of 250 men and women gathered in the natatorium to hear the speech making. A meeting was also held last night by the Young Men's Democratic club, which is in favor of the candidacy of C.R. Morehead, but it was not as enthusiastic as the other one, the attendance being about 150.

Fred Delgado, one of the policemen who took off his star and enlisted in the Morehead campaign early in the fight, stated to a Herald reporter today that he is now for White for mayor.

March 3, 1917

Yesterday afternoon a meeting of about 20 women was called for the purpose of organizing a woman's charity association, with the object of co-operating with the "charity union of El Paso." Mrs. C.B. Eddy was elected president; Mrs. J.P. Ramsey, vice

president, and Mrs. M.P. Schuster. The members, besides the officers, are: Mrs. E.W.S. Neff, Mrs. S.H. Sutherland, Mrs. H.L. Newman, Mrs. Joseph Magoffin, Mrs. E. Kohlberg, Mrs. Jacobo Blanco, Mrs. J.S. Morrison, Mrs. W.H. Austin, Mrs. H.W. Allen, Mrs. W.S. McCutcheon, Mrs. C.R. Morehead, Mrs. O.C. Irvin, Mrs. J.C. Lackland, Mrs. W.H. Burges and Mrs. H.D. Slater.

March 5, 1903

Two political meetings were held last night. The rally held in the court house by the supporters of Morehead turned out to be a gathering of 140 people to listen to a few tirades of abuse for the leading members of the White campaign. The meeting of the Young Men's White campaign club was held in the Masonic temple and was attended by a large crowd.

March 6 1903

Registrar J.C. Jones is now about 100 ahead of W.M. Peticolas. The Morehead men are working hard and are putting in many men. Harry Charman is helping the Dwyers and Ike Alderete today and D. Storms, who yesterday was apparently a spectator, is rushing Mexicans in also. The White leaders still have Frank Alderete on duty challenging the men he does not know.

March 19, 1903

The Young Men's Democratic (Morehead) club held its regular meeting last night in the court house, and, according to the court made by secretary C.W. Marshall, of the meeting, there were 85 present.

March 21, 1903

At the Morehead meeting Wednesday night, former city treasurer C.W. Fassett, referring to the fact that mayor B.F. Hammett has placed the city on a cash basis said, deprecatingly: "At this time of year the city is al-

ways out of debt. The taxes collected will keep it on a cash basis for a few months, when it will begin to run behind. The same conditions have at ways existed and the city is in no better condition than it ever was.”

March 30, 1903

C.R. Morehead, candidate for mayor, returned from his California trip yesterday, feeling well.

April 4, 1903

The Moreheadites made the supreme effort of their lives to have a showing at their meeting last night in the opera house, which they succeeded in doing as far as numbers are concerned. There were 900 people there, 100 more than at the White meeting the night before. Among the speakers were president Frank Morris, judge W. Kemp, A.S.J. Eylar, Zack Cobb and Samuel Freudenthal. Senor Zamonia talked to the Mexican people present.

April 14, 1903

White is probably safe; Morehead is behind in every ward. The voting began early and proceeded briskly, without disorder and with all the safeguards provided by law.

April 16, 1903

The count of the vote last night after the polls had closed showed that C.R. Morehead had carried the city in every ward, by pluralities ranging from 46 in the fourth ward to 136 in the third.

Mayor B.F. Hammett and mayor elect Morehead were out riding this morning in mayor Hammett's buggy.

April 17, 1903

The city council, which has served the city for the past two years, held its last meeting this morning, and after canvassing the votes cast at the recent election, declared the fol-

lowing elected: Mayor C.R. Morehead; alderman for the second ward, J.W. Magoffin and J.B.W. Burton; for the first ward, George Look and H.R. Charman; for the third ward, T.H. Springer and J.T. Grant, for the fourth ward. W.J. Rand and J. Brunner; for treasurer, J.H. Smith; collector, B.F. Jenkins; recorder, S.J. Eylar. By the time the installation was over, many friends had gathered at the city hall and extended a hearty welcome to the newly made officials.

April 20, 1903

Mayor Morehead set at rest all speculation as to whom he would and who he would not appoint, when, this afternoon, he announced all appointments excepting three in the police and health departments. They follow: Sewer commissioner, George C. Wimberly; city attorney, D. Storms; city auditor, S.J. Gatlin; sanitary commissioner, Sam Dwyer; city clerk, Ben S. Catlin.

April 24, 1903

Last night the first meeting of the new city council was held, with mayor Morehead in the chair.

April 25, 1903

Most all of the old policemen are leaving the force. Mayor Morehead, it is thought, will fill all vacancies by Monday.

April 27, 1903

That the preachers of El Paso want the law enforced was given out by Rev. J.F. Kellogg, chairman of the committee consisting of Rev. Henry W. Easter and Rev. D.L. Collier, who were chosen to draft a resolution to present to mayor Morehead.

April 28, 1903

It is said today that mayor C.R. Morehead offered to appoint Harry Wood chief of police, but that it was declined.

May 1, 1903

Tomorrow is to be elected the new school board. Mayor Morehead's organ has announced four candidates—E.C. Pew, B. Bryan, W.N. Vilas and T. J. Beall. The citizens are showing very little interest in the election, and there will be no fight.

May 2, 1903

The election for school trustees is in progress today, but owing to the fact that the citizens not in favor of the Morehead candidates have no representation on the ticket, the vote is very light.

May 3, 1903

Tomorrow, if nothing happens, mayor Morehead will name the new chief of police. Some say it will be Mitchell, others, Rogers, Neimayer, McGhee, Jones and Davis, while some of the old cool headed politicians say that there is a dark horse, and that all will be surprised when the announcement is made.

June 19, 1903

Mayor C.R. Morehead and members of the sanitary committee of the council will serve on the joint committee on public charity, with county judge J.U. Sweeney and commissioner S.J. Freudenthal. The mayor said today that at least one of the committee and himself would meet today and probably all of the committee.

July 24, 1903

Ground was broken for the new brewery yesterday. Mayor Morehead threw the first shovel of dirt and the aldermen followed. Work will now be pushed forward at as fast a rate as possible.

August 11, 1903

Mayor C.R. Morehead discusses the telephone matter. Declaring that he will not sanction any franchise that does not fix a maximum rate of service. "I think that it is

time that these corporations did something in turn for the franchise given them by the people. I think that the editorial in The Herald expresses the matter just about as every one in El Paso thinks."

August 22, 1903

Ed Halverson, the fireman who was ordered removed by the city council Thursday night, is still on duty and his friends say that he will remain there. Fire chief Frank Powers had a conference with mayor Morehead yesterday on the subject, but declined to state the result of the conference.

October 8, 1903

Congressman W.R. Smith, of Colorado, Tex., is a guest of the city. He arrived last evening. At 9 o'clock this morning, escorted by mayor C.R. Morehead, Maj. W.J. Fewel, Beauregard Bryan, Dr. W.N. Vilas, Captain Juan S. Hart, and Horace B. Stevens. Mr. Smith started for Fort Bliss, where he desires to become familiar with the situation with a view to supporting the recommendation of Gen. Grant for a larger post at this place.

October 22, 1903

Congressman William R. Hearst, of New York, and his party of national lawmakers who are touring the territories in quest of information on the subject of whether or not they should be admitted to statehood, arrived in El Paso yesterday afternoon. A delegation of prominent citizens rode out to intercept the visitors. Those composing the delegation were Mayor Morehead, H.L. Newman, Judge Dean, judge Bryan, E.M. Bray, Capt. John P. Casey, A.G. Foster, Horace D. Stevens, W.W. Follett, Joseph U. Sweeney, Park W. Pitman, Juan S. Hart, city attorney D. Storms, judge F.E. Hunter, Maj. W.J. Fewel and Richard Caples.

January 2, 1904

Mayor C.R. Morehead returned last evening from a short visit to California.

January 24, 1904

“I think that bunco men are a good thing for a city situated as El Paso is. The bunco men get money from strangers that might not otherwise be left here, and the money is put in circulation in this city, thus adding to the general prosperity.” So said police chief Wootton Saturday night to contractor D.W. Schoonmaker, a Morehead supporter in the late election.

February 14, 1904

C.R. Morehead, mayor of El Paso has written a vigorously worded letter to the chief of police, in which the mayor tells the chief the police must either get busy and clean up the moral condition of the city or else get out of office.

February 18, 1904

Mayor C.R. Morehead and the fire and water board held a special meeting yesterday afternoon for the purpose of discussing the water rates now charged. The question of sprinkling the streets with oil was discussed and the proposed plan may be tried.

March 13, 1904

Mayor C.R. Morehead, city engineer G.C. Wimberly and a party of aldermen paid a visit to the headgate and canal work along the river front today. It is reported that they are not satisfied with the results obtained.

March 19, 1904

Mayor C.R. Morehead and alderman John Burton engaged in a personal encounter in front of the city hall at 11:48 this morning.

April 29, 1904

Alderman Will Rand, representing the Fourth ward, announced today that he will

resign from the city council at its next meeting, giving as his reason that the office takes too much time from his business. It is known, however, that he is not in harmony with mayor Morehead.

July 11, 1904

The El Paso Republican leaders may decide not to oppose Pat Dwyer for the legislature. Jack O’Keeffe, probably will succeed present mayor Morehead, with Jim Rogers, chief of police.

August 31, 1904

Mayor C.R. Morehead, of El Paso, has issued a proclamation naming Monday, September 5, as Labor day, and calling on all good citizens to fittingly observe the day.

September 19, 1904

Mayor C.R. Morehead, of El Paso, has ordered no licenses granted to gambling houses in the city after October first. If they operate after that date, It will be in secret and without the protection of the city. General talk among the citizens indicates that the long suffered vice is doomed.

November 9, 1904

While mayor Morehead is decidedly reticent on the gambling situation, chief of polite F. Hall give an order that all gambling houses must be closed up tight.

November 11, 1904

It’s all off tonight! Public gambling ceases, and the sheriff gives notice that he proposes to enforce the statutes of the state to the letter, no matter .who may be affected by the action. The end has been set for 2 oclock tomorrow morning. Mayor Morehead is very noncommittal on the gambling question and refuses to promise his aid in rooting out the evil. He scores the newspapers for “Advertising our rottenness to the outside world,” and says: “If all the liars were taken out of

El Paso, there wouldn't be a corporal's guard left." Chief of police F.J. Hall declares that gambling in the reservation must stop, that variety theaters and dance halls must close and robbing cease.

November 25, 1904

Politics are warming up considerable for the spring election. Richard Caples is being talked of as the man who can defeat mayor Morehead in the primaries.

December 26, 1904

A movement to put Capt. Charles Davis in the race to succeed C.R. Morehead in the spring as mayor was launched this morning and it is an established fact that he will be the next mayor of El Paso.

February 10, 1905

Mayor Morehead and chief of police Francis Hall decided this morning that Louis Vidal would be allowed to conduct his dance hall so long as perfect order should be maintained. An officer will be stationed at the door of both his hall on Utah street and the dance hall on Seventh street to see that order is maintained.

February 11, 1905

Mayor C.R. Morehead was "under the weather" Thursday evening and less than a quorum of the aldermen gathered. at the appointed council meeting. No business was transacted by the body.

February 19, 1905

Col. W.C. Greene, distinguished miner and capitalist, and his party, arrived in his private car, "Starlight," this morning at 8 oclock attached to the Rock Island train. His car was immediately switched to the Southwestern yards, where it was attached to the outgoing Southwestern flyer. The party left at 9:46 for Cananea, where the properties in that district will be inspected. A committee

of El Pasoans, composed of A.P. Coles, C.R. Morehead, Joseph Magoffin, J.A. Smith, H.B. Stevens, Richard Caples, A. Krakauer, H.J. Simmons, B.F. Hammett, W.W. Turney, and Chas. DeGroff was appointed to call upon Col. Greene. Because of the uncertain arrival of his train, as a result of the blocked condition of the roads, the entire committee could not be brought together to make the call.

March 3, 1905

P.E. Kern, a former El Pasoan, has sent a small Masonic emblem in the form of a gavel to mayor C.R. Morehead from Alaska. It is made of the tusk of an extinct mastodon and is very pretty.

April 2, 1905

Mrs. Jacobo Blanco, president of the Woman's Charity association, presided at a meeting held in the Sheldon. In her address to the members she mentioned the gratitude felt by the members toward the physicians who have aided them during the past three months, Drs. Rawlings, Vilas, Schuster, Coffin, Thompson and B.F. Stevens, also doctors at Hotel Dieu. Thanks were also extended mayor Morehead, judge Sweeney, Ben Catlin, Park Pitman and other officials who have been kind and courteous.

April 8, 1905

Mayor Morehead has appointed a new city jailer to take the place of Jim Dwyer. The new police official is Juan B. Larrazolo, jr., son of a former district clerk and district attorney of El Paso, who is now prominent in New Mexico politics and is considered to be probable United States senator for New Mexico, when it becomes a state.

May 2, 1905

Mrs. B.F. Hammett presented to the city the pictures of the city hall and six mayors, Ma-

goffin, Caples, Campbell, Hammett, Morehead and Davis.

June 10, 1905

C.R. Morehead is back from California.

August 10, 1905

Ex-mayor C.R. Morehead is confined to his home on Myrtle avenue with typhoid fever.

August 20, 1905

C.R. Morehead left for California over the Southern Pacific this morning.

August 22, 1905

C.R. Morehead left for California today.

September 15, 1905

C.R. Morehead has returned from a visit to California.
